AMERICORPS: TO SUPPORT RECRUITMENT, TRAINING AND PLACEMENT OF 11 FULL AND PART-TIME AMERICORPS MEMBERS IN 8 LOCAL HOST ORGANIZATIONS THAT PROVIDES A BROAD RANGE OF SERVICES. AMERICORPS MEMBERS WORK WITH HOST ORGANIZATIONS TO BUILD ORGANIZATIONS' CAPACITY TO EFFECTIVELY MANAGE AND PARTICIPATE IN DIRECT SERVICE AND SUPPORT ROLES AS NEEDED. THE MEMBERS ARE TRAINED TO PROVIDE DIRECT SERVICES THAT ELEVATE THE KNOWLEDGE AND EDUCATION OF LOW LITERATE, ECONOMICALLY DISADVANTAGED, ADULT JOB-SEEKERS AND ENTRY LEVEL EMPLOYEES IN BASIC SKILLS INSTRUCTION, INCLUDING ADULT LITERACY THAT IS DIRECTLY LINKED TO WORKFORCE DEVELOPMENT AND OCCUPATIONAL TRAINING ACTIVITIES. A SIGNIFICANT PIECE INCLUDES CONTEXTUALIZING THE LITERACY CURRICULUM IN SEVERAL SECTOR PATHWAYS. CONTEXTUALIZED CURRICULUM USES AUTHENTIC MATERIALS AND ACTIVITIES THAT CONNECT THE LEARNERS TO THE OCCUPATIONS AND INDUSTRIES THEY ARE INTERESTED IN. IT PROVIDES INSTRUCTION WITH EXAMPLES THAT ARE AUTHENTIC TO THE WORK WORLD.
